## **Professorship of Immunology of Early Metastasis (grade W 3).**

The position provides the legal status of civil servant (Beamtenverhältnis) for life and is to be filled as soon as possible.

The professor should strengthen the faculty in the focal points of tumor research and immunomedicine. Specifically, the professor should work on the interaction of disseminated tumor cells with immune cells and organ cells during metastatic colony formation. We expect the professor's work to be thematically connected to the collaborative research center TRR 305 (Striking a moving target: From mechanisms of metastatic organ colonisation to novel systemic therapies). In addition, the professor should enable the building of a bridge to translational research by cooperating with the Fraunhofer Institute for Toxicology and Experimental Medicine (ITEM) in Regensburg which researches in the area personalized tumor therapy.

We are looking for a person who has shown excellence in early-stage systemic cancer research and has great willingness to cooperate with other disciplines in regional, national and international networks. In the future, the professor should integrate their work with that of other professorships, which have not yet been filled, creating an innovative interdisciplinary department for immunomedical research. The conditions provided by the Faculty of Medicine and Universität Regensburg to do this are attractive, including existing connections to immunology research areas, and the non-university research institutions, the Leibniz Institute for Immunotherapy and the Fraunhofer group for personalized tumor therapy. In particular, paths leading from basic research to diagnostic or therapeutic applications should be found in collaboration with the Fraunhofer group and TRR 305. Involvement in medical, biomedical and scientific teaching is expected.

Prerequisites for taking up the position are, alongside the general conditions from public sector employment law, a completed university degree, pedagogic suitability, particular aptitude for academic work, generally shown by a doctoral degree, and further academic performance shown via a habilitation or equivalent which may have been performed outside higher educational institutions or as part of the duties of a junior professor.

Universität Regensburg is particularly committed to reconciling family and working life (for more information, see <http://www.uni-regensburg.de/familienservice>). To fulfill the equality directive and increase the number of female professors, we explicitly encourage applications from qualified women.

In case of essentially similar suitability, applicants with severe disabilities are given preferential consideration.

The prerequisites for appointment under civil servant law are based on the provisions of the Bavarian Public Service Code (BayBG) and the Bavarian University Staff Act (BayHSchPG). Please note the age limit specified in Art. 10 Para. 3 BayHSchPG.
